The Lesotho Highlands Development Authority (LHDA) invites interested, eligible and suitably qualified Individual Consultants to indicate their interest in the Provision of Consultancy Services: Livelihood Restoration Specialist within the Resettlement and Development Branch.

The objective of the assignment is for the Consultant to assist the LHDA with the proper conceptualization and the best practice of operationalization of livelihood improvement interventions within the Lesotho Highlands Water Project (LHWP) in line with the Livelihood Restoration and Social Development Framework (LR&SDF) and Livelihood Restoration Plan.

The Consultant will further be required to assist the LHDA in the initial setting up of the Business Enterprise Development Unit (BEDU), reviewing LHDA Contract 6032 (C6032 – Professional Services for Development of a Social Development Master Plan for LHWP Phase II), providing technical assistance in efficient and effective implementation of the various livelihood restoration interventions including, but not limited to, interventions proposed under the Livelihood Restoration and Social Development Framework, concept plans developed by LHDA Contract 6015 (C6015 – Professional Services For Resettlement Planning and Implementation: Polihali Site Establishment and Reservoir Area, livelihood restoration spin-offs recommended by C6032).

The terms of reference (TORs) including key tasks for the Consultant are as follows:

1. Provide Literature Review.
2. Provide support and guidance in enhancing Divisional staff capacity.
3. Coordinate implementation of an LHDA wide Livelihood Restoration Programme.
4. Development of a Stakeholder Engagement Plan.
5. Manage feasibility assessment of approved Livelihood Restoration Concept Plans to pre-implementation stage.
6. Monitor and evaluate performance of the development interventions under implementation.
